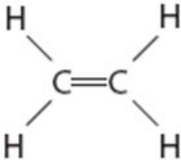
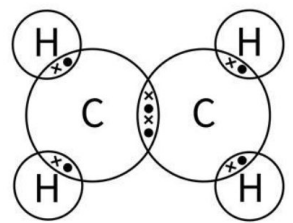
- All candidates must receive the same treatment. Examiners must mark the first candidate in exactly the same way as they mark the last.
